# BEST PRACTICE - I Private and Corporate Scholarship for deserving students

## **OBJECTIVES**

Financial assistance of any kind in however modest a form is an aspect of regular functioning that educational institutions which cater to students from mixed or predominantly middle and lower middle class grapple with in some form or the other.

## CONTEXT

A vast majority of our students hail from average middle-class families. Many of these reeling as they were from the ravages (both financial and emotional) of Covid unfortunately found it difficult to regain financial stability. This in turn expectedly adversely affected enrolment rates. Realizing the gravity of the situation and the sheer helplessness of students who were genuinely deserving and desirous of pursuing an education, the college consulted the management for individual, benevolent donors and also actively sought corporates that would be willing to undertake financial aid for education as a part of their CSR activities.

#### PRACTICE

In this context we were fortunate to find a corporate sponsor / donor in Indiabulls. An amount of Rs. 7,51,800 was received from India Bulls for disbursement. 36 students were the beneficiaries. Besides corporate donorship the management of the Cosmopolitan Education Society found some generous individual / private donors who donated an amount of Rs 75,000 A notice was circulated and deserving students were invited to apply. While Indiabulls had stipulated eligibility conditions for a student to be a beneficiary , private donors entrusted the task of identifying deserving beneficiaries to the discretion and judgement of the college authorities.

#### **EVIDENCE OF SUCCESS**

58 students were beneficiaries of a total amount of Rs. 806800. This assistance not only contributed to ease the financial burden of the families of the beneficiaries, it served an even greater impact -as a morale boosting incentive. Students were grateful to be at the receiving end of a selfless act of generosity and it replenished their faith in the goodness of humanity. They were also appreciative of the fact that the institution cares for them as proved by the efforts taken.

#### **PROBLEMS ENCOUNTERED**

One of the greatest obstacles that we encountered was the strict documentation that the corporate donor required as eligibility criteria. For eg – many of our students come from homes where parents work in professions that do not have the provision of a salary certificate or such other kinds. These kind of lack of documentary support proved to be a hindrance in the receipt of aid for a few truly deserving students.

# **BEST PRACTICE - II**

# Cyber Shiksha For Cyber Suraksha

## **OBJECTIVES**

To recruit students as warriors in the war against cyber crime.

To create awareness among students through multiple means- orientation sessions, quiz, social media feeds and the creative medium of street plays.

## CONTEXT

In a world dominated by the presence of technology in our daily lives and living, an unwelcome downside is the alarming proliferation of incidents of cyber fraud and scams on unsuspecting and unaware users. In this context, the only way to arm oneself against such attacks is to be aware, alert and cyber security literate.

### PRACTICE

As a part of the Quick Heal program of Earn and Learn, the QHF team visited various colleges and provided an induction program for students. Interested students enrolled for the training process. This training process was a joint collaboration by Maharashtra cyber and Quick Heal Foundation.

On completion of training students visited various schools and colleges to spread awareness about cyber security.

In 2022-23 the target allotted to us was 40,000 and we succeeded in sensitizing 74000 students.

# **EVIDENCE OF SUCCESS**

This outstanding performance was recognized by QHF with the awards we received. Our students Mr. Jigar Akhade and Ms.Rumana Shaikh were felicitated with the 'Cyber Suraksha Warrior of the Year Award'. Our faculty Mr. Sandeep Kamble received the Cyber Suraksha Champion of the Year-Teacher under Best Process Compliance Category

Students and faculty involved in the training process also received a remuneration to the tune of Rs5,09600.

Besides the tangible monetary takeaways and awards perhaps one of the most significant outcomes of this endeavor was the impact the entire exercise had on our students.

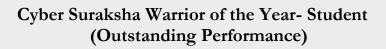
IT students while skilled in technology and it's uses often are found lacking in areas like communication and presentation skills.
