

Scholarships /Freeships

Students can avail of the following Scholarships and Freeships. Completed application form along with necessary certificates should be submitted to the college office within one month from the commencement of the academic year.

➤ Freeship for Economically Backward Class Students (Only for B. Com)

- Family income of the student not exceed Rs.12,000/- per year.
- Should be a Domicile of Maharashtra State.
- Income Certificate from the Tahsildar or Employer for the preceeding year should be attached
- E.B.C. Freeship application along with Xerox copies of Family Ration Card and Statement of marks of previous two years.

➤ Freeship for Primary/Secondary teachers Pupils. (Only for B. Com)

Children of Primary/Secondary Teachers are eligible for PTC/STC Freeship. Documents to be attached with PTC/ STC freeship form are:

- Xerox copies of Statement of Marks of previous two years
- Xerox copy of the family Ration Card containing applicant's name
- Employment Certificate from the School Authority, stating the educational qualifications of parents and the class taught by the parents of applicants.

➤ Educational Concession to Children of Ex-Servicemen (Only for B. Com)

The children of Ex-Servicemen are eligible for the above-mentioned educational concession. Following documents are required to be submitted:

- Prescribed Educational Concession form duly filled (intriplicate)
- Xerox Copies of Statement of Marks of previous two years
- Proof of service in Defence forces by the parent.

➤ Government of India Post S.S.C. Scholarship/ Freeship. (For all programs except BMS & BSc (IT) & MSc (IT))

Students belonging to SC/ST/DT-NT and OBC / SBC categories are eligible for the above-mentioned Scholarship/ Freeship. Following documents are required to be submitted:

- Prescribed application form duly filled in
- Xerox Copies of statement of marks of previous year.
- HSC Marksheet
- Copy of Caste Certificate in the name of the student issued by District Magistrate, Assistant Collector or Tahasildar of State of Maharashtra stating that the caste is recognized under Reserved Category in the State of Maharashtra.
- Income Certificate from Tahsildar for OBC/SBC, VJNT & for SC category - Form 16 and Tahsildar (2021 – 22) (Below Rs.250000/-)
- Non -Creamy Layer Certificate for students belonging to VJNT/ST/DT/SBC and OBC categories.
- Copy of ration card containing applicant's name.
- Xerox copy of Aadhar Card.
- Domicile Certificate in student name
- Bank Passbook First Page Xerox (Student Account).

➤ **Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulkh Shishyavrutti Scheme for Open Category**

Following documents are required to be submitted

- Annual income certificate from the Tehsildar office
- Family Declaration Certificate about two children
- Applicants' Domicile certificate
- Attendance certificate with 50% attendance
- Admission Fee receipt
- Previous year marksheet
- Bank passbook photocopy
- Domicile certificate

➤ **Association of Non-Government Colleges (ANGC) Scholarship**
